Summary of Proposed Bylaw changes 6/3/2016 For actual detailed verbiage, please review the posted copy of the proposed changes in the Tiki Bar or review a copy (available here).

Change #1 (location in Bylaws) Article III Officers, Section 1

To be added -Fleet Captain office constitutes a Work Detail (same as 'A' member 7 hr. per month requirement)

Change #2 (location in Bylaws) Article IV, Section 1

To clarify verbiage -after officer completes R/C, V/C and Cmdre. They can initiate "exempt for work assignment". Once the past Cmdre initiates (initiation needs to start at new year-after change of watch) once initiated, the exempts must be taken in consecutive 3 year period.

Change #3 (location in Bylaws) Article VI, Membership

Remove and reword -Drop membership types 'B' and 'C'. Current B members will remain current B type and remain until the B member changes membership status.

C is actual an 'A' member that chose a "buyout" for that year.

Change #4 (location in Bylaws) Article VI Membership

To clarify verbiage -Honorary Member and their requirements.

See actual changes on the next two pages.

As stated in our By Laws : ARTICLE XIV AMENDMENTS SECTION 1.

1. The Secretary shall read the proposed amendment to the Board of governors meeting following receipt.
2. Following the reading to the Board all proposed amendments or new by-laws shall be reviewed by the Board of Governors. Who shall rule on their merit and feasibility and then will be submitted to the membership with recommendations, if any.
3. Following the action taken by the Board of Governor the Secretary shall read the proposed amendments to the membership at the next Regular or Annual Membership Meeting.
4. Following the reading to the membership, a copy of the proposed amendment shall be displayed on the Club bulletin board until the proposal is voted upon.
5. A copy of the proposed amendment shall be furnished to each member within fifteen (15) days of the reading at the membership meeting.
6. At the next Regular or Annual Membership Meeting following the meeting at which the proposed amendment was read to the membership, the proposed amendment shall be called for vote. An affirmative vote by a two-thirds (2/3) majority of the member present and entitled to vote shall be sufficient to ratify a proposed amendment.

By Law change 1 ARTICLE III OFFICERS Section 1 Proposed Change Article III Sec 1 (c)

Explanation: This change would spell out that our current flag officers would be exempt from assigned work assignment by virtue of their office which spells out their duties.

Current (e) *The Flag Officers and the Fleet Captain must, at the time of their election and during their term of Office be the owners of a power cruiser of not less than twenty feet (20') in length with overnight accommodations, operable, waterborne and able to participate in Eastern Yacht Club cruises.*

CHANGE Add BOLD

(e) The Flag Officers and the Fleet Captain must, at the time of their election and during their terms of Office, be the owners of a power cruiser of not less than twenty feet (20') in length with overnight accommodations, operable, waterborne and able to participate in Eastern Yacht Club cruises. **By the virtue of being a Flag Officer and Fleet Captain, these offices will constitute their work detail assignments.**

By Law change 2 Commodore Proposed Change Article IV Sec 1 (g)

Explanation: This change explains how many years off for servings as Commodore, Vice Commodore and Rear Commodore and how it can be taken off

CURRENT (g) *After completion of Office, a Past Commodore will receive a gold colored membership card and he/she will be exempt from all assigned work details for a period of one (1) year for each year served in office, except on a voluntary basis (approved 8/2/91). A past Commodore will still be required to pay all dues and/or assessments.*

CHANGE Drop strikethrough Add BOLD

(g) After completion of Office, a Past Commodore will receive a gold colored membership card and he/she will be exempt from all assigned work details for a period of one (1) year for each year served in office, except on a voluntary basis (approved 8/2/91). **consecutive year served in office as Commodore, Vice Commodore and Rear Commodore. These (3) years can be used at the start of any new season (after change of watch) after their completion as Commodore. Once this option is initiated, the "time off" term must be of consecutive years.** A past Commodore will still be required to pay all dues and/or assessments.

By Law change 4 ARTICLE VI MEMBERSHIP Proposed Change Article VI sections 4 (a)

Explanation: This will explain the requirement if an active members is given honorary membership

CURRENT (a) *The Board of Governors may award Honorary Membership to such persons as it may deem to have rendered important service or benefits to the Club. Such membership shall be awarded on an annual basis and shall require a two-thirds (2/3) majority of the Board members present and voting at any Board meeting. Honorary Members shall not be required to pay dues or any assessment, and shall be entitled to all privileges of the Club with the exception of voting, holding office and establishing seniority and slip privileges*

CHANGE SECTION 4. HONORARY MEMBERSHIP, add change BOLD

(a) The Board of Governors may award Honorary Membership to such persons as it may deem to have rendered important service or benefits to the Club. Such membership shall be awarded on an annual basis and shall require a two-thirds (2/3) majority of the Board members present and voting at any Board meeting. **Active member who are made an Honorary Member will be required to pay dues or any assessment and continue working on bona fide committee.** Honorary members who are non-members shall not be required to pay dues or any assessment, and shall be entitled to all privileges of the Club with the exception of voting, holding office and establishing seniority and slip privileges.

BY LAW CHANGE # 3 is on the next page.

By Law change 3

Art VI sec. 1 (a), Art VI sec. 2 (b), Art VI sec.2 (c), Art VI sec. 2 (d) and Art VI sec. 3 (d)
Changes to Article VI Sections of Membership should be voted on as one by-law change to ensure continuity.

Explanation: By Law Change 3. The intent of these changes would be to drop B and C Membership after all current B members have changed their membership to Class A member or to social member or no longer continue as a member. Currently we have two B members. To clear up how a member becomes a buyout member, to explain the switch from social member to Class A member.

ARTICLE VI MEMBERSHIP Proposed Change Article sections 1 (a)

CURRENT Six (6) types of membership shall be carried on the membership rolls: Regular Class A, B, C, Social, Honorary, and Associate.

Drop current ART VI Sec. 1 (a) to this CHANGE

The membership shall consist of Class A, Social, Honorary and Associate.

Clean up the entire by laws by dropping all reference to Regular Members

ARTICLE VI MEMBERSHIP Proposed Change Article VI sections 2 (b) Drop strikethrough and add change BOLD

(b) Regular member – A Regular **Class A Member** must be a participating member who shall be required to pay all dues, assessments and fees as may be required by the Rules and by-laws of EYC. Said member shall also be required to contribute not less than seven (7) hours of work per month on a bona fide committee, as directed by the chairman of said committee. If any regular member **Class A member** shall miss a work assignment, he/she will be fined in the amount set by the BOG and approved by the general membership by a simple majority. If a member misses 2 or more work assignments in the club fiscal year he/she shall be called before the BOG for possible disciplinary action. If said member was able to arrange a swap with another member, with the approval of the committee chairman, no assessment shall be levied.

(Amount of fine was changed at September 2010 meeting by the membership from \$75.00 to \$150.00 fine for missed work assignment, approved.)

Proposed Change Article VI sections 2 (c) Drop strikethrough and add change BOLD

CURRENT (c) Regular Membership Class B: A Regular Member Class B shall be required to pay dues, assessments and fees as may be required by the rules and by-laws of EYC, but will not be eligible for slip privileges. A Regular Member Class B must assume Class A duties for six months prior to gaining slip privileges.

(c) As of this day (date of GMM acceptance of By-Law proposed changes) a ‘B’ Membership will be eliminated from the ‘Membership’ type. ‘B’ members currently on the rolls will remain ‘B’ members until their membership status changes. Once membership doesn’t contain any ‘B’ member on the rolls, the ‘B’ Membership section will be eliminated. Class B shall still be required to pay dues, assessments and fees as may be required by the rules and by-laws of EYC, but will not be eligible for slip privileges. A Regular Member Class B must assume Class A duties for six months prior to gaining slip privileges.

Proposed Change Article VI sections 2 (d) Drop strikethrough and add change BOLD

Current (d) Regular Membership Class C: A regular member must be a participating member who shall be required to pay all dues, assessments and fees as may be required by the rules and by-laws of EYC. For all new members joining after April 1, 2004 in order to be excused from the regular assignment of duties as outlined for a regular member in paragraph (b), said member shall also pay an annual fee at the time of payment of dues in an amount established by the Board of Governors. Members having joined prior to that date will pay the existing rate plus any annual increases which will be limited not to exceed 10% of the current rate per year and voted on by the General membership by a simple majority. All new members wanting to buy out, the initial amount will be set by the Board and raised at the approval of the General Membership by a simple majority. A new member will not be eligible to buy out work duty until they have been a member in good standing of EYC for a minimum of 5 years.

CHANGE (d) **Class A member shall submit a letter to the BOG requesting to buy out and shall also pay an annual buy out fee at the time of payment of dues in an amount established by the Board of Governors. Members will pay the existing rate plus any annual increases which will be limited not to exceeding 10% of the current rate per year set during BOG meeting in July and voted on by the General membership by a simple majority. For all members wanting to buy out, the initial amount will be set by the Board and raised with the approval of the General Membership by a simple majority. Member will not be eligible to buy out from work duty until they have been a member in good standing of EYC for a minimum of 5 years consecutive.**

ARTICLE VI MEMBERSHIP Proposed Change Article VI sections 3 (d)


