Upon receipt of your application it will be forwarded to the membership committee for review. A personal interview by the membership committee will be conducted. Your application must be posted in the club house for a minimum of thirty (30) days after which time your application will be presented to the Board of Governors for action. Following approval by the Board of Governors a membership card and a copy of the By-Laws of EYC will be issued to you at the next regular meeting. You will be placed on a one year probationary period.

Should you be rejected by the Board of Governors all fees will be promptly refunded. In the case of a rejection, no reason shall be given and the decision of the Board of Governors is final.

Regular Members credits will be billed each February. Social Members will be billed 1 time per year. Annual dues are billed 1 time per year. All bills are due when presented. A \$20.00 late charge is imposed after final due date. Non-payment of bill or fines will result in termination of membership.

Class B members changing to Class A member you must work as a Class A Member for a minimum of 6 months before becoming eligible to bid on a slip at EYC.

Upon attaining slip privileges a Pier Maintenance fee is required.

Boats must be seaworthy, presentable, able to run under their own power and be maintained. All boats will be subject to an initial acceptance inspection and an annual inspection performed by EYC's pier committee.

Holding Corporation Stock Purchase: \$300
